In connection with gambling investigations, the Special Service Bureau of the Dallas PD has been carrying on an undercover operation involving a number of bookies operating in Dallas. It has already made felony cases on two bookies and hopes to make additional cases before obtaining warrants of arrest so as to keep their undercover man effective as long as possible. One of the principal bookies already made is GARLAND EUGENE POLLARD, subject of Dallas pending case. The other bookie is an agent for POLLARD. Our investigation and informants show that POLLARD is working for HARRY REMER **<u>YURBAN,</u> SR., DL 165-114, and URBAN in turn is believed to be** getting his betting line from PHILIP S. BOSCO, DL 92-331. Suspecie ? URBAN is to be retried in State Court on 3/1/68, on prior LA Cost A felony conviction which the State Appellate Court overturned. 500 31000 URBAN is also awaiting Federal prosecution in USDC, Dallas, position in based on charges filed by IRS for wagering without a stamp. The Dallas Office is assisting the Dallas PD in its operation and maintaining close contact for any indication that the line is coming from out of state.
