In view of the sensitivity of this source, caution should be exercised in reporting the information contained in this letter and suitable paraphrasing should be used.

As a matter of background, the following is set forth:

MM 800-C advised SA FRANK J. SMITH on October 1, 1962, that JAMES PALMISANO, aka, and STEFANO RANDAZZO, aka, would open a restaurant-lounge with adjoining motel units at 15090 Biscayne Boulevard, Miami, Florida. In a conversation with PALMISANO, MM 800-C learned that the place was a "natural" for gambling. Investigation revealed that the physical plant consisted of two main buildings which were formerly occupied by the La Scala Restaurant and adjoining motel units.
