NK 2207-C-TE said DANZO realized what FRANZESE was driving at, since prior to the above questions, FRANZESE had treated him to a big dinner and drinks, during part of which FRANZESE talked about how JOE BONANNO had fouled things up, had tried to throw his weight around and grab everything for himself.

DANZO told FRANZESE he did not care what happened to SAL PROFACI, JR., as long as SAL's wife and kids were provided for.

Informant said DANZO is not a made member of LCN, but is under FRANK SALERNO, age 70-72, 5'8" - 10", slender build, brown eyes, thinning gray hair, wears thted glasses and expensive clothes, resides Lafayette St., just off Prince St., NYC. SALERNO is DANZO's cousin and is a "consuleri" in the GENOVESE LCN "family".

Informant said SAL PROFACI, JR., is in the JOE COLOMBO "family" of LCN and his "captain" is JOE YAKOVELLI.
