TOTAL DENIAL

Re San Diego airtel dated 1/25/68, which sets forth information furnished by SD-1064-C-TE, concerning one JACK POLLINA, an LCN member who illegally entered the U.S. and settled in Detroit, except for a period of three years during which time he lived in the San Diego area and worked in an Italian restaurant.

Enclosed herewith is a copy of a photograph of one GUISEPPE PALENA, aka Joseph Palena, and Jack Paleny, obtained from the files of the U.S. INS at Detroit, Mich., on 2/1/68.

INS file indicated that PALENA was born on 11/14/23, at Chieti, Italy. He illegally entered the U.S. in 1953 and has been the subject of INS deportation case since that time. His file indicated residence in Detroit from the period 1953 to present but failed to indicate that any verification of his residence was ever made.

The file revealed PALENA's current residence is 3916 West Point, Dearborn Heights, Michigan, and his employment as owner and operator of the original Joe's Restaurant, 3913 S. Telegraph Road, Dearborn Heights. He was married in Detroit on 1/10/63, and has lived at the above residence since that time.

PALENA is represented by a Detroit attorney named HARRY KOBEL, an ex-U.S. immigration official who has represented in numerous instances individuals associated with known LCN families in Detroit.

San Diego is requested to display the enclosed photograph to SD-1064-C-TE in an effort to determine if PALENA is identical with the JACK POLLINA previously mentioned by him.
