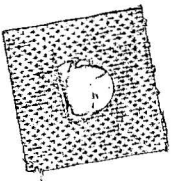
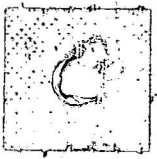

SILVIO CARMELO PERRETTA

The Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised on February 28, 1968, that SILVIO CARMELO PERRETTA, a U. S. citizen born in Pittsburgh, Pennsylvania, on July 26, 1919, arrived in Ripacandida (Potenza), Italy, on July 15, 1967, and resides in this community with his family. He has been authorized by the Italian Government to remain in Italy until October 15, 1968. At the present time he is connected with the Iannetta lumber firm of Vulture (Potenza). He is the owner of an Opel Cadet automobile, tagged with Potenza plate number 36926, and very frequently drives to Naples, Italy, in this automobile.

To date he has not been involved in any illegal activity.
