LA FOUR SEVEN ONE ONE C-TE IS THE PRIMARY OPERATOR AND MONEY MAKER FOR LA LCN INTERESTS. THESE INTERESTS INCLUDE TWO PANGUINGUE CARD CLUBS WHICH INFORMANT HAS DESCRIBED AS BEING INVESTED IN BY LCN LA AND LCN NEW YORK.

ONE CLUB THE ALMONT CLUB, IS FRONTED BY LA GAMBLER MANUEL RICKY JACOBS WHO IS CURRENTLY UNDER FEDERAL INDICTMENT LA FOR INVOLVEMENT IN CHEATING AT BEVERLY HILLS FRIARS CLUB. JACOBS IN NINETEEN SIXTY FIVE KNOWN TO BE BUSINESS PARTER OF NEW YORK BOOKMAKER HERBERT LIEBERT, DECEASED, AND HIS PARTNER CHARLES MEYERSON. LA FOUR SEVEN ONE ONE C-TE ADVISES TOTAL AMOUNT OF MONEY INVESTED BY MEYERSON AND LIEBERT WAS ONE HUNDRED EIGHTY THOUSAND AND THIS MONEY WAS PUT UP AND CONTROLLED BY LCN FAMILY IN NEW YORK WHICH WAS FORMERLY HEADED BY THOMAS LUCHESE (DECEASED). INFORMANT ADVISED THIS MONEY STILL INVESTED AND NEW YORK INTERESTS ARE EXTREMELY CONCERNED OVER IT. THE PANGUINGUE CLUBS HAVE NOT OPERATED FOR PAST TWO YEARS BECAUSE OF HARASSMENT BY LAW ENFORCEMENT AND PASSAGE OF SPECIAL ORDINANCES OUTLAWING PANGUINGUE. A NEW HEARING ON PANGUINGUE IS SET FOR MUNICIPAL COURT BEVERLY HILLS APRIL THREE NEXT TO DETERMINE ITS LEGALITY.
