[GUARINO, IT SHOULD BE NOTED, WAS THE INDIVIDUAL WHO SAVED FRANKIE "T" MARI'S LIFE ON SEVEN THIRTEEN SIXTYSIX, WHEN MARI WAS WOUNDED THREE TIMES BY THE BONANNO FACTION. GUARINO, ACCORDING TO INFORMANT, SHOT AND KILLED THE BONANNO MAN WHO OTHERWISE WOULD HAVE SLAIN MARI.]
