DL T-1 advised that the subject has not been out of town and specifically did not attend the funeral of VITO GENOVESEE last month.

DL T-1 advised on March 27, 1969, that after numerous attempts by the subjects, he has finally consented to go to the Zuroma Club with the subject on the night of April 3, 1969. He once said the club meets every Thursday night and it is the subject's turn to be the host. He stated the reason that he traveled to New Orleans with the subject when the subject went to Baton Rouge to visit his brother-in-law was due to the fact that he (T-1) was going to New Orleans on a business trip. He said that he obtained an airline reservation for both himself and the subject. He stated the subject was met in New Orleans by relatives who drove him to Baton Rouge.

DL T-1 advised on April 11, 1969, that the subject appears to be recovering fairly well from his recent heart attack. He stated he attributed this to the fact he saw the subject mowing his lawn at his home just the day before. He was advised that the subject's brother CHARLES CIVELLO has been sick with the flu and had not been appearing in the store as regularly as usual. He advised that he had not gone to the meeting of the Zuroma Club with the subject as he had been out of town at the time. However, he states that he intends to go the next time it is the subject's turn to be the host.

On May 8, 1969, the subject was observed by SA JOHN J. LANDERS in the Airways Liquor Store, 3122 West Mockingbird Lane, at approximately 12:30 p.m. The subject appeared to be working at the time.

On May 20, 1969, the subject was again observed by SA JOHN J. LANDERS in the Airways Liquor Store at approximately 2:15 p. m. and some all appearances, he was working in the store.

It is noted this report covers only that period during which file was reviewed commencing on or about 1/18/69, to current date report submitted, and prior dates included in details are not included. While CIVELLO has been seen at the Airway Liquor Store on numerous occasions in the past, no effort was made to list all the instances in the report, but merely to show that for the past several years he continues to be in touch with the store.

No further review of CIVELLO'S deposition and Dallas file is being made until the USA, San Francisco gives some indication as to whetherinformation furnished by CIVELLO is susceptible to possible perjury and if so what portions he considers possible perjury.

The informants set forth in the details are not available for testimony.

On September 27, 1968, DL T-1 advised that while it mightappear that JOSEPH CIVELLO has no connection with the Airway Liquor Store on West Mockingbird Lane, near Love Field, she was present when CHARLES CIVELLO, brother of JOSEPH, called the owner of the real estate where the store is now located, in 1959, to arrange for the lease of the property. The source related that at that time JOSEPH CIVELLO was present with CHARLES CIVELLO and JOSEPH CIVELLO was the one who gave CHARLES CIVELLO instructions on what to say when he talked to the owner about the lease. The source advised that after CHARLES CIVELLO talked to the owner on the telephone, CHARLES and JOSEPH CIVELLO left reportedly for downtown Dallas to the Republic National Bank to obtain the necessary money required by the lease.

The files of the Dallas Office show that on November 18, 1959, Detective H. M. HART, Intelligence Section, Dallas Police Department, advised that CHARLES EDWARD CIVELLO (subject's brother), and ROSS MUSSO, their brother-in-law, have applied for a liquor license for the Airway Liquor Store, 3122 West Mockingbird Lane.

The files further show that on September 24, 1959, DL T-2, advised SA ROBERT P. GEMBERLING that JOSEPH CIVELLO, either directly or through his brother, CHARLES EDWARD CIVELLO, had leased a piece of property on Mockingbird Lane, Dallas, Texas, near Love Field Airport, on which he plans to construct a liquor store. Source stated he believed an individual by the name of MUSSO would also be connected in this enterprise. Further that the property leased to CIVELLO was done through the owner of the property, CARL C. WEICHSEL, President, Great National Life Insurance Company, Dallas, Texas.

The files of the Dallas Office further show that on May 15, 1961, ED BUTLER, Operator of the Humble Service Station, located at the corner of Cedar Springs and Mockingbird Lane, located close to the Airway Liquors, furnished the following information to SA ROBERT M. BARRETT.

BUTLER advised that CHARLES CIVELLO and ROSS had been very steady customers up until May 1, 1961. JOE CIVELLO would occasionally come by for gas but nothing else. They charged all their purchases on a personal charge account under the name "Airway Liquor Store" and the bills were paid by check drawn on an account at the Exchange National Bank. BUTLER stated however, that since May 1, 1961, none of the above had been in for any business.
