For information of Dallas and Detroit, referenced airtel advised that SD 1064-C-TE advised that Los Angeles LCN Boss NICK LICATA recently told informant that Detroit LCN Boss JOE ZERILLI instructed LICATA to travel to Miami, Florida area so that he could be introduced to members of the LCN Commissione.

LICATA told informant that he would leave Los Angeles, probably with his wife, on 12/27/68, and return to Los Angeles about 1/15/69.

For information of the Bureau and receiving offices, LA 4412-C-TE advised that on 12/3/68, LICATA told him that he planned to make a trip "back east" around the Holidays as he had to meet with many people.

On 12/11 '68, LA 4412-C-TE advised that on that date, LICATA told him that he and his wife were leaving 12/27/68, for Miami, where he would be staying with WILLIAM "BLACK BILL" TOCCO (Detroit LCN leader who has a winter home in Miami area). TOCCO is the father-in-law of LICATA's son, CALEGERO (CALC) LICATA, an LCN member in Detroit.

LICATA told informant that he already has plane reservations and after spending some time in Miami, he will go on to Detroit and then return to Los Angeles between 1/15 and 20/68.

A check of all major airlines on 12/12 '68, at Los Angeles failed to locate a reservation for LICATA to Miami or Detroit on 12 26 or 27 68.

On 12 18 68, LA 4412-C-TE advised that LICATA instructed him to meet with him in the Los Angeles area prior to 12/27 68. Informant plans to meet LICATA 12 23 or 24 68 and will attempt to elicit more detailed information concerning above trip.

In view of the fact LICATA, according to LA 4412-C-TE, has used the name PHILLIP CRAIG on motel registers recently in the Palm Springs area (that name must not be mentioned outside the FBI in connection with LICATA), a recheck of National Delta, United and American airlines was made on 12/20/68 for a reservation in the names NICK LICATA and PHILLIP CRAIG for flights to Miami, Dallas and Detroit on 12 27 68 with negative results.

Dallas was included in view of the fact SD 1064-C-TE advised that TOMMY PALERMO, Los Angeles LCN "consiglieri" was recently in Dallas visiting LCN Boss JOSEPH CIVELLO.

CIVELLO attended the Appalachin meeting with former Los Angeles LCN Boss FRANIC DESIMONE.
