On 12/22/68, NK 2376-C-TE, advised that JOE ZICARELLI has been acting as a type of referee and advisor in the continuing problems besetting the JOSEPH BONANNO family. According to the informant, ZICARELLI has been meeting with representatives from the BONANNO family at a restaurant on 32nd Street, Union City, New Jersey.

The informant stated that PAUL SCIACCA continues as the new head of the family with FRANKIE T. (TN FRANK MARI), as the second in command. The position of the third in charge has not been filled, although ZICARELLI has been proposed for the job. His advice has been sought constantly by "the people from New York."
