On 12/30/68, NY 4336-C-TE advised that FRANKIE "T" MARI, "underboss" in the SCIACCA "family" of La Cosa Nostra (LCN), was presently in Miami, Florida, and had been there for approximately a week.

Informant explained no specific knowledge as to the reason for MARI's visit in Miami other than that MARI had expressed the intention of meeting some high ranking members of LCN there.

Informant stated that he and MARI had made tentative plans to meet together in San Juan, Puerto Rico, on or about 1/20/68 for vacation purposes.

Bureau and Miami will be advised if any further specific information is received concerning MARI's activities in Miami.
