The following information was received from SD 1064-C-TE on 12/3/68 and 12/13/68. He furnished the following information on La Cosa Nostra (LCN) members and other hoodlums:

I. LOS ANGELES DIVISION

On 11/25/68, informant drove to San Clemente, California, where he met FRED SICA and CHRIS PETTI. Upon instructions received from Los Angeles LCN Boss NICK LICATA, he informed SICA that the Los Angeles LCN Family, under LICATA, was going to cut in on bookmakers and loan sharks
