ReBulet to San Francisco dated December 3, 1968.

SF-2689-C-TE was interviewed on December 10, 1968, and he was questioned concerning his knowledge of the activities of ~~RUSSELL BUFALINO~~ of Pittston, Pennsylvania. Informant advised that he knows BUFALINO by name only from prior information concerning BUFALINO's association with JOE CERRITO and JAMES LANZA in connection with the Apalachin meeting of November 14, 1957. He stated that as far as he knows, ANGELO BRUNO is still the "boss" of the Philadelphia, Pennsylvania, area and he has never heard anyone describe RUSSELL BUFALINO as a "boss" of his own LCN Family.
