JOSEPH ZERILLI, aka.,
ARRe Detroit airtel dated 1/7/69 to the Bureau,
captioned, "LA COSA NOSTRA, AR - CONSPIRACY".

DE 889-C-TE on 1/13/69 advised that JOE ZERILLI had been confined to St. John Hospital in Detroit, Mich. on 1/12/69 and was expected to be kept in the hospital for a period of about three days for a checkup. Informant stated that ZERILLI has indicated that he plans to attend a dinner-dance to be held by the American-Italian Delegates Club in Detroit on 2/14/69 and may go to Miami, Fla. after that.

No information has been developed by Detroit indicating that any major hoodlums planned travel to Miami during the first half of 1/69. Travel by members of the family of BLACK BILL TOCCO to Miami is being set forth under separate communication.
