KC 358-C-TE on 1/22/69 advised SA ROY L. TUSSEY as follows:

FRANK TOUSA, a member of the Kansas City "Outfit", which is synonymous with the LCN, told this source on 1/22/69 that the two biggest bookmakers in Las Vegas, Nevada, have stopped disseminating the "daily basketball line" because of statements recently attributed to the new Attorney General of the United States relating to the use of wire tapping against organized crime. TOUSA said that he telephonically contacted his sources in Las Vegas for a "line" on 1/21/69 and was told that his sources have discontinued for the time being. As of 1/21/69, TOUSA, who directs bookmaking activities of the Kansas City "Outfit" does not have an available basketball line which has curtailed bookmaking activities in Kansas City.

Above source advised that MIKE LASCUOLA, another Kansas City bookmaker, has complained to this source that the "basketball lines" out of Las Vegas, Nevada, have dried up because of the new Attorney General's statements relating to the use of wire tapping by FBI against organized crime.
