

No information has been developed indicating that JOSEPH ZERILLI, LCN boss in Detroit, plans any travel to Miami, Florida, during the month of January, 1969. It is noted that WILLIAM "BLACK BILL" TOCCO, ZERILLI's brother-in-law, and an LCN elder statesman resides in Miami, Florida, during the winter months.

It is further noted that TOCCO's daughter is married to CALO LICATA, son of NICK LICATA, LCN boss in Los Angeles, California. With regard to the information furnished by LA 4412-C-TE concerning the use of the name PHILLIP CRAIG by NICK LICATA on motel registers, it should be noted that PHILLIP CRAIG (true name PHILLIP CRACCHIOLA) is a Detroit attorney who is a brother-in-law of NICK LICATA. CRAIG has two brothers and neither of them are known to have any close association with Detroit hoodlum activities. reportedly are not held in very high regard by the hoodlum element in Detroit.

The Bureau and interested offices will be kept advised of any information developed indicating travel to the Miami area by Detroit hoodlums.
