RAUL VARANDELA ESTEVEZ (SJ file 105-16189; Bureau file 105-266071) is currently under investigation for his activities in connection with ORLANDO BOSCH's anti-Castro Cuban-exile group, Accion Cubana (Cuban Action) which has taken credit in the past for bombings of Cuban embassies in 1974. JOSE CALIXTO SANTIAGO VALDES (SJ file 105-11871; Bureau file 105-240481) was previously of operational interest to G2 and it has never been established that he is not currently working in that capacity.

On 8/7/75, the records of the Police of Puerto Rico (POPR), Office of Intelligence, were caused to be reviewed by SA JAMES PATRICK LAFLIN. Records revealed no identifiable information regarding subject.

By written communication the POPR formally requested that all records, documents or information in any form which that agency furnishes to the FBI be specifically exempt from any disclosure whatsoever in regards to the Freedom of Information Act, with amendments, and the Privacy Act of 1974. Accordingly, any agency subsequently receiving this information is considered bound by this request.

On July 23, 1975, SJ T-1 stated that the subject was a good friend of Raul Varandela Estevez and that this individual had a reputation for being pro-Castro. (X)(u)

Source further advised that he had seen Jose Calixto Santiago Valdes and Raul Varandela Estevez in La Tacita Cafeteria, in the vicinity of Roosevelt and De Diego Avenues, approximately six months ago. Upon seeing source, Santiago and Varandela became very nervous and left La Tacita Cafeteria a few minutes after his arrival. According to source, Santiago, a proven Cuban Intelligence Officer, knew that he, source, was aware of certain specifics relating to his covert operations for the Cuban government. The source added Varandela is also likely to be associated with a Cuban Intelligence operation in Puerto Rico. Source noted that Rodriguez was a member of Luciano Nieves' group, Partido Laborista (Labor Party) which attempted to open a diplomatic link with Castro in 1973. (X)(u)

[On October 3, 1975, SJ T-4 stated] that the subject may be identical to Alberto Rodriguez, who owns a school of music on Roosevelt Avenue and who also owns the School of Languages.

P.R.

On October 6, 1975, a review of the records of the Immigration and Naturalization Service (INS), San Juan, Puerto Rico, reflected subject to have INS file #A12891022. The file revealed subject was born on April 27, 1934, in Santo Domingo, Cuba, he is 5'10" tall, has black eyes and black hair. Rodriguez entered the United States in Miami, Florida, on February 17, 1962.

Instant file reflected the following trips outside the United States made by the subject:

June, 1966 for three months duration through Central and South America

January, 1973, for one month duration through Venezuela, Santo Domingo, Jamaica and Costa Rico

January 14, 1974, three days traveling through Santo Domingo, Venezuela and Spain

In February, 1975, Rodriguez listed his residence as Guatemala #795 Las Americas, Rio Piedras, Puerto Rico, and employment as International Language Center, F. D. Roosevelt #301, Hato Rey, Puerto Rico.
