MAURICE H. FRIEDMAN, a part owner of the New Frontier Hotel, Las Vegas, Nevada, is a very close friend of ROSSELLI. He has been associated in several business ventures in Las Vegas with ROSSELLI; for example, the Carver House Hotel and Marina, Inc. In addition, information was received from LV 39-C\* which indicated that ROSSELLI might possibly have some interest in the New Frontier Hotel in Las Vegas. LA 4268-C, during the past several months, has reported that ROSSELLI and FRIEDMAN are together at the Friar's Club in Beverly Hills on nearly a daily basis when FRIEDMAN is in the Los Angeles area. Information received from other informants indicate that ROSSELLI and FRIEDMAN associate socially, and frequently go to dinner and night clubs together.

FRIEDMAN resides in Las Vegas, but comes to Los Angeles several times each month and on some of these occasions, stays as long as several weeks. When he comes to the Los Angeles area, he stays at the Beverly Crest Hotel, 125 South Spalding, unless for some reason he is unable to obtain a reservation. A review of information concerning his visits to Los Angeles since about October, 1961, reflects that he frequently is assigned to Room 415, which is a corner room on the fourth floor. If he is not assigned to this room, he is usually assigned to some other room on the fourth floor.
