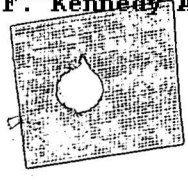

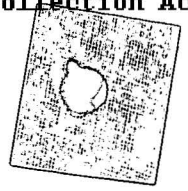

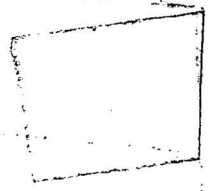

On February 14, 1960, a confidential informant, who has furnished reliable information in the past, advised that Cuban Minister Counselor Enrique Patterson was recently informed by the Cuban Consulate in Miami, Florida, that the hearing on the extradition of Ferner head of the Cuban Air Force, Pedro Diaz Lora, is scheduled for March, 1960. The informant said Patterson is very much upset over the manner in which this case has been handled and can see no excuse for the delay, indicating that both the Miami Consulate and the Embassy in Washington, D. C., have been at fault for not pursuing this matter more vigorously. The informant advised that Patterson was stated that beginning immediately the Diaz matter will be given every attention in order that it might be brought to a logical conclusion, but Patterson has not as yet decided whether to approach the United States Department of State in this case at this time or simply pursue the matter through the court in Miami and approach the Department of State at a later date.
