Enclosed for the Bureau are nine copies of a letterhead memo and evaluation memo dated and captioned as above.

The information in enclosed letterhead memo was furnished by WF [1161-S] to SA DONALD HOETING on 5/31/61. It should be noted that on 5/26/61, above informant advised that MANOLO RAY refused an invitation to speak before the Cooperative Forum in Washington, D. C. The informant advised SA HOETING that he telephonically contacted RAY on 5/29/61, and again requested RAY to accept the invitation to speak before the Forum. The informant stated that he wanted to impress RAY that a refusal to speak before the Forum in light of his recent withdrawal as the MRP Representative to the Revolutionary Council in the U. S. would undoubtedly have adverse effect upon any future recognition of MRP by the U. S.](X)(u)

Concerning the Cooperative Forum, in March, 1945, [C-286] who is now [WF 987-S*,] advised that the Cooperative Forum (S) meets weekly in Washington, D. C. Its membership consists principally of important government officials, commentators and newsmen, and is usually well attended by foreign diplomatic personnel. Current topics of importance are discussed and members agree not to discuss the subject matter of the Forum outside of the meeting. The meetings are well organized, and a principal speaker is designated and invited, and usually a general discussion among the members pertaining to the meetings' subject matter follows. X

The letterhead memo is classified "Confidential" since the data reported could reasonably result in identification of a confidential informant of continuing value and compromise the future effectiveness thereof.
