Enclosed to the Bureau are 9 copies of a letterhead  
memorandum and evaluation memorandum dated and captioned as  
above.

The information in enclosed letterhead memorandum was  
furnished by WF 1161-S to SA DONALD HOETING on 6/9/61 concerning  
the meeting in Washington, D.C., attended by MANOLO RAY, head  
of anti-CASTRO organization, Movimiento Revolucionario Del  
Pueblo at the Cooperative Forum.

Concerning the Cooperative Forum, in March, 1945,  
[C-282] who is now [WF 987-S\*] advised that the Cooperative  
Forum meets weekly in Washington, D.C. Its membership consists  
primarily of important government officials, <sup>members</sup> and  
newsmen, and is usually well attended by foreign diplomatic  
personnel. Current topics of importance are discussed and  
members agree not to discuss the subject matter of the Forum  
outside of the meeting. The meetings are well organized and  
a principle speaker is designated and invited, and usually  
a general discussion among the members pertaining to the  
meeting's subject matter follows.

The letterhead memorandum is classified "Confidential"  
since the data reported could reasonably result in identification  
of a confidential informant of continuing value and compromise  
the future effectiveness thereof.
