Concerning the Cooperative Forum, in March, 1945, C-282, who is now (WF 987-S\*, advised that the Cooperative (5) Forum meets weekly in Washington, D.C. Its membership consists primarily of important government officials, commanders and newsmen, and is usually well attended by foreign diplomatic personnel. Current topics of importance are discussed and members agree not to discuss the subject matter of the Forum outside of the meeting. The meetings are well organized and a principle speaker is designated and invited, and musually a general discussion amongs the members pertaining to the meeting's subject matter follows:
