[redacted] PSI (Under development), on 7/22/63
advised that MANOLO RAY returned to Puerto Rico on 7/18/63.
RAY stated at meeting that he travelled to Europe via
Washington, D. C. and New York City, where he conferred with
exile leaders. RAY was accompanied on trip by EMILIO GUEDES,
JURE leader in San Juan. RAY travelled to Paris, France and
to Belgium. He met with leaders of Comite Cultura y
Libertad de Francia, a Cuban exile organization in France,
the leaders of which for the most part are exiled journalists,
and was soliciting their cooperation and support as Cuban
exiles. In regard to Belgium portion of trip, he neither
denied nor confirmed that he was inquiring concerning arms. (X)(u)
