Mexican Immigration officials at Mexico, D. F., 9/19/72 advised that they have received a report that on subject was in the state of Jalisco. They advised that Immigration agents would be sent to Jalisco in an attempt to locate subject. They stated that in the event he could be located he would be brought to Mexico City to be processed for deportation and would probably be sent to San Antonio, Texas. On 9/25/72 JAIME GUTIERREZ QUIROZ, Chief of Inspection Department of Mexican Immigration Service, Mexico, D.
