GENERAL INVESTIGATIVE DIVISION - CUBA

Miami Confidential Informant MM 501-C was recontacted on July 12, 1955, at which time he advised that IRVING SCHILLER of New York City, who used to be a chauffeur for ARNOLD ROTHSTEIN, who was slain in New York many years ago, now controls gambling in the Panamanian Hotel, Panama City, Republic of Panama.

He advised that among American gamblers connected with Cuban gambling activities at the present time are GILBERT SEIDER, wa. "APPLE" SEIDER, "DOC APPLE". This gambler, who maintains a home on Miami Beach, is originally from Detroit, Michigan, and according to informant, is associated with the Montmartre Club, Havana, Cuba.

Informant advised that in addition to DINO and EDDIE CELLINI, one PATSY ROSE, originally from Detroit, Michigan, is also connected with the Tropicana Club at Havana, Cuba. Informant stated that MARTINE FOX and RAMON ADULA now have 75 slot machines in operation at the Tropicana. He believes these machines were shipped in from Chicago, Illinois, but could furnish no specific information.

He advised that NORMAN ROTHMAN has been "squeezed out" of the Sans Souci Night Club and Casino, Havana, Cuba, but could furnish no specific details in that regard. He advised that it is his understanding that ROTHMAN is now trying to promote a Spanish-American Club in the downtown section of the city of Havana, but again he could furnish no specific details.

In accordance with previous Bureau instructions, any other data concerning American gambling activities in Cuba will be furnished as learned.

Two additional copies of this letter are being furnished the Bureau in the event they desire to furnish copies to the Legat, Havana, Cuba. RUC.
