ReBuairtel to Miami dated 6/21/67 in case file on MIRR, IS - CUBA; NM - CUBA (Bufile 97-4474, Miami file 105-2855).

Enclosed for the Bureau are 10 copies of an LHM dated and captioned as above.

Pursuant to Bureau instructions, copies are being disseminated locally to INS and Secret Service.

MM T-1 mentioned in the LHM is MM 639-S. Information originally appeared in Miami LHM dated 4/22/66 in the MIRR case file.

The information relating to the arrests and trials of subject obtained through the office of U. S. Customs, Miami, on October 13, 1967, was specifically obtained from Customs Agent STANLEY SCHACHTER.

The interview of MULET on May 1, 1967, relating to MIRR activities by FRANK FIORINI was set out in Miami LHM dated 5/19/67 in the case captioned "FRANK ANGELO FIORINI, aka; ET AL, REPORTED PLANS TO BLOW UP CUBAN SHIP IN MEXICAN PORT, POSSIBLY VERACRUZ" (Bufile 105-165503, Miami file 105-12890.)

No recommendation is being made for subject's inclusion on the Security Index since he does not fit the criteria of Section 87d of the Manual of Instructions
