I. PREDICATION

MM T-1, who is acquainted with some members of the Cuban Nationalist Movement in New York City, advised on June 5, 1967, that a meeting took place on June 3 - 4, 1967, in the New York area. Present were IGNACIO NOVO, Secretary General of the Movimiento Nacionalista Cubana (Cuban Nationalist Movement - CNM), his brother, GUILLERMO NOVO, both of the New York City / Newark area, Dr. ORLANDO BOSCH, head of the Movimiento Insurreccional de Recuperacion Revolucionaria (Insurreccional Movement of Revolutionary Recuperation - MIRR), and Dr. MANUEL A. DE VARONA, head of the Rescate Revolucionaria Democratica (RRD), an anti-FIDEL CASTRO organization of Cuban exiles (S)(U)

MM T-1 reported that future plans of anti-CASTRO Cubans were discussed and these plans centered in Canada. BOSCH wanted to carry out a two-pronged attack against the Cuban Government in Canada. He specifically spoke about the assassination of the Cuban Ambassador to Canada and an attack on a Cuban ship in the port of Montreal (S)(U)

BOSCH, according to MM T-1, explained that they would not use a member of the CNM because they were too "hot". BOSCH said that his man "GUTIERREZ" in Miami had nine rockets, timing devices, C-3 and C-4 (explosives) which could be used in their future plans. He related that the Cuban exiles wanted to show the United States Government, the FBI, and the Immigration and Naturalization (S)(U)

Service that what action had been taken against FELIPE RIVERO, National Director of the CNM, could not stop the Cuban exiles in their fight against Prime Minister FIDEL CASTRO of Cuba. (S)(U)

MM T-1 stated that BOSCH told the NOVO brothers and Dr. DE VARONA that upon his return to Miami he would have "GUTIERREZ" send the necessary equipment to one of his, BOSCH's, men in the New York area and coordinate further plans with the CNM through the NOVO brothers. BOSCH did not further identify "GUTIERREZ" (S)(U)

MM T-1 said that during the entire discussion, Dr. DE VARONA did not make any comment concerning the plans of BOSCH. (S)(U)

CUBAN NATIONALIST MOVEMENT

The MIRR is a small action group of anti-FIDEL CASTRO Cuban exiles headquartered in Miami, Florida, under the leadership of ORLANDO BOSCH AVILA, a former medical doctor in Cuba. Since 1961, members of the MIRR have been involved in numerous and almost continuous activities of a revolutionary nature, including bombing raids, attempted raids, sabotage, demonstrations, and propaganda.

The CNM is a small action group of anti-CASTRO Cuban exiles with members in Miami, Florida, and the New York City area. Its leader, FELIPE RIVERO DIAZ, was arrested and incarcerated at Miami on May 12, 1967, by the Immigration and Naturalization Service on revocation of his parole. Prior to his arrest, RIVERO had claimed credit publicly on behalf of his organization for firing a bazooka shell at the United Nations building, New York City, on December 14, 1964, and for three explosions which took place in Canada at other times. He has also admitted that the CNM had plans for an action against the Cuban pavilion at Expo 67, Montreal, Canada.
