it was not deemed advisable to interview SCHARFF for the following reasons:

SCHARFF is presently Agent in Chargeof the United States Customs Bureau, Houston, is up in years and has been a member of the Government Service for a very long period of time. It has been the experience of the Houston Office that SCHARFF is prone to allow his mind to wander at times with the ultimate result that imagination runs away with him. In addition SCHARFF during the course of contacts in the past, has prefaced the majority of his comments on his own personal opinions and is unable to substantiate his personal opinions by actual facts.

The Houston Division is of the opinion that even though SCHARFF was interviewed under suitable pretext, he may possibly discuss the interview with FERTITA, who has been most friendly and cooperative with the Houston Division and of course this would not be desired by the Houston Division.

It is worthy of pointing out that individuals listed in the Details of this report were interviewed under suitable pretext and no disclosure was made to any outside source that the Bureau was conducting an inquiry relative to the MAFIA.
