SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. CG 6486-C\* REPORTED NO PERTINENT ACTIVITY DURING SEPTEMBER 14 LAST. CG 6457-PC ADVISED THAT DOMINIC BLASI, GIANCANA LIEUTENANT, PREVIOUSLY HAD AMBER LOUNGE IN CICERO, FROM WHICH HE CARRIED ON BOOKMAKING ACTIVITIES. HE MOVED THIS OPERATION TO THE MITCHELL TAVERN, CICERO, WHERE IT WAS RUN FOR HIM BY WILLIE WILLIAMS WITH THE GAMBLING STAMP BEING ISSUED UNDER THE NAME OF HELEN MICHELLE, WILLIAM'S GIRL FIREND.
