SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. CG 6486-C\* ADVISED YESTERDAY DURING EARLY AFTERNOON THAT SAM GIANCANA WAS IN CONFERENCE WITH AN UNKNOWN INDIVIDUAL. THIS UNKNOWN INDIVIDUAL IS BOB LNU\* KNOWN FROM CONTEXT OF THE CONVERSATION TO BE A CLOSE ASSOCIATE OF ALDERMAN [REDACTED] 28TH WARD, CHICAGO, ALSO RECENTLY NAMED AS CLERK OF THE COOK COUNTY PROBATE COURT. [REDACTED] IS A PCI OF THE CHICAGO DIVISION. HIS ASSOCIATION WITH HOODLUMS HAS BEEN KNOWN BY CHICAGO FOR SOMETIME. HE IS UNDER DEVELOPMENT AS A PCI HAVING BEEN RECENTLY OPENED. IT IS KNOWN THAT ALTHOUGH HE HAS DISPLAYED A COOPERATIVE ATTITUDE HE HAS NOT FURNISHED NEARLY ALL THE INFORMATION IN HIS POSSESSION PERTAINING TO HIS KNOWLEDGE OF CHICAGO HOODLUMS. THE CONVERSATION REFLECTS THAT THIS INDIVIDUAL OPERATES A LARGE VENDING MACHINE OPERATION FOR GIANCANA. DURING THE EARLY PART OF THE CONVERSATION, THE FOLLOWING WAS DISCUSSED: UNKNOWN - "THERE'S SOMETHING THAT I PROMOTED ABOUT 2 MONTHS AGO, SINCE I HAVEN'T SEEN YOU. I JUST WANTED YOU TO KNOW. HIS NAME IS ED JULIUS. THEY HAD HIM ASSIGNED JUST TO YOU." GIANCANA - "WHAT DEPARTMENT IS HE WITH?" UNKNOWN "INCOME TAX. THIS FELLA WAS JUST ASSIGNED TO YOU. ONLY TROUBLE WAS HE WAS PROMOTED. BUT UP TO THAT TIME, WE KNEW EVERYTHING. I JUST WANTED YOU TO KNOW. I TOLD YOU HE WAS OUR FRIEND. SMART GUY. DON'T WORRY ABOUT THAT. HE KEEPS ME INFORMED ABOUT EVERYTHING." GIANCANA
