 CLAIMS WHEN DEAL CONSUMMATED, HAYES ESTABLISHMENT TO BE OPERATED
 BY FRANK SINATRA, POPULAR SINGER, AS FRONT FOR SUBJECT. ACCORDING
 TO PCI DEAL NEVER COMPLETED. IT IS NOTED ARTHUR ADLER WAS
 ALLEGEDLY FRONT FOR HOODLUMS IN NORTH SIDE CHICAGO RESTAURANTS,
 WHOSE BODY WAS FOUND IN CHICAGO, FEBRUARY 1960 AFTER OBVIOUSLY
