SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. RE DAILY SUMMARY OF OCTOBER 20 LAST PERTAINING TO [redacted] BEING IN CONTACT WITH GIANCANA. [redacted] CONTACTED AGAIN OCTOBER 20 LAST BY BUAGENIS RE HIS KNOWLEDGE OF AFFAIRS OF GIANCANA. [redacted] NOT QUITE AS LUCID AS LAST CONTACT, DID NOT ADMIT A CLOSE ASSOCIATION TO GIANCANA. CONVERSATION DIRECTED TO VENDING OPERATIONS, AND CANTEEN SERVICES, AND [redacted] VOLUNTEERED THAT HE KNOWS MUCH ABOUT SUCH OPERATIONS THROUGH HIS GOOD FRIEND, ROBERT PETRONE OF OASIS DISPENSING COMPANY. NOTED THAT CG 6486-C HAS ADVISED IN PAST THAT PETRONE CONTACTED GIANCANA RE THE OPERATION OF OASIS, ALSO ADVISED GIANCANA ABOUT ED JULIUS, IRS AGENT. [redacted] WAS ASKED IF HE HAD ANY PART OF OASIS VENDING, DENIED SAME. HE WAS ASKED ABOUT SOME OTHER GIANCANA ENTERPRISES AND WAS VAGUE IN RESPONSE, EXCEPT PERTAINING TO EVANSTON AND RED TOP CAB COMPANIES, WHICH HAVE BEEN ALLEGED TO BE BRIBED BY GIANCANA. [redacted] WAS ADAMANT IN STATING THAT GIANCANA HAD NO PART OF THOSE COMPANIES, STATING HE HAS KNOWN FRED BARTOLI AND SAM LEVINE FOR MANY YEARS, DESCRIBING THEM AS HARD WORKING, LEGITIMATE OPERATORS WHO WOULD HAVE NO PART OF GIANCANA. AS A MATTER OF FACT, STATED [redacted] AN OFFER WAS MADE BY UNIDENTIFIED HOODLUMS SOME TIME AGO TO BACK BARTOLI AND LEVINE, WHICH OFFER WAS TURNED DOWN. FURTHER CONTACTS ARE CONTEMPLATED WITH [redacted] RE HIS KNOWLEDGE OF HOODLUMS, HOWEVER, IT IS NOT EXPECTED THAT HE WILL BE COMPLETELY COOPERA-
