SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. YOU HAVE BEEN PREVIOUSLY ADVISED OF THE FACT THAT CG 6486-C\* HAS STATED ON SEVERAL OCCASIONS OF AN ASSOCIATION BETWEEN GIANCANA AND [REDACTED] OTHER 4

[REDACTED] ALDERMAN, TWENTYEIGHT WARD, CHICAGO, AND RECENTLY APPOINTED AS CLERK OF THE PROBATE COURT OF COOK COUNTY.

[REDACTED] WAS OBSERVED BY BUAGENTS ON ONE OCCASION RECENTLY MAKING CONTACT WITH DOMINIC BLASI NEAR THE ARMORY LOUNGE APPARENTLY IN PROCESS OF MAKING CONTACT WITH GIANCANA. [REDACTED] HAS BEEN UNDER DEVELOPMENT FOR SOME TIME BY SA WILLIAM F. ROEMER AS A PCI. YESTERDAY, AFTER SUFFICIENT TIME HAD ELAPSED SO AS NOT TO JEOPARDIZE THE SOURCE [REDACTED] WAS CONTACTED BY BUAGENTS ROEMER AND RALPH R. HILL WITH THE VIEW TOWARD ESTABLISHING HIS RELATIONSHIP AND ACTIVITIES WITH GIANCANA AND OTHER HOODLUMS SUCH AS MURRAY HUMPHREYS, ET AL. HE WAS TOLD THAT "NUMEROUS PERSONS" HAD ADVISED OVER THE MONTHS THAT HE, [REDACTED] WAS BECOMING CLOSE TO SUCH PEOPLE AS GIANCANA, ET AL. HE WAS NOT TOLD OF THE NATURE OF THE INFORMATION FURNISHED BY THESE PERSONS, AND WAS TOLD THAT HIS COOPERATION WAS DESIRED IN FURNISHING HIS INTERPRETATION OF HIS RELATIONSHIP WITH GIANCANA. HE THEN ADMITTED THAT HE KNEW "MOE" (MOST USED ALIAS OF GIANCANA), AND HAD MET WITH <sup>NITA</sup> ON SEVERAL OCCASIONS DURING THE PAST SEVERAL MONTHS. HE SAID THE MEETING WAS ALWAYS PRECEDED BY A PHONE CALL FROM SOMEONE TO MEET GIANCANA AT A DESIGNATED LOCATION. HE DESCRIBED THE REASONS FOR SOME OF THESE MEETINGS AS FOLLOWS:

ONE, GIANCANA DESIRED ACTION TO QUASH REVOCATION PROCEEDINGS AGAINST A TAVERN OPERATOR WHOSE LICENSE WAS UNDER FIRE. TWO, GIANCANA CONTACTED [REDACTED] TO ASCERTAIN WHAT [REDACTED] KNEW ABOUT SA ROEMER. THREE, GIANCANA ADVISED [REDACTED] THAT IN VIEW OF NEWSPAPER PUBLICITY CONCERNING JACK CERONE, JR., IT WAS NOT NECESSARY FOR [REDACTED] TO FURTHER SPONSOR CERONE, JR., FOR BAILIFF OF CHICAGO MUNICIPAL COURT. [REDACTED] TOLD GIANCANA THAT THIS WAS NOT NECESSARY, AND HE WOULD CONTINUE HIS SPONSORSHIP OF CERONE, WHICH PLACED [REDACTED] IN GOOD STEAD WITH GIANCANA. ARRANGEMENTS MADE FOR FURTHER INTERVIEW OF [REDACTED] THIS DATE, IN THAT YESTERDAYS INTERVIEW WAS TERMINATED BY AN APPOINTMENT OF [REDACTED] EFFORTS WILL BE MADE TO ASCERTAIN FULL DETAILS OF REASONS FOR GIANCANA'S INTEREST IN SA ROEMER. IT IS FEET THAT [REDACTED], IF COMPLETELY COOPERATIVE, COULD DEVELOP INTO A VALUABLE SOURCE OF INFORMATION, AND FOR THAT REASON THIS IS BEING FOLLOWED CLOSELY. ARMED AND DANGEROUS. u
