SAMUEL M. GIANCANA, AKA AR. DAILY SUMMARY. RE WHEREABOUTS OF GIANCANA, CG 6457-C ADVISED YESTERDAY THAT MICHAEL ACERRA, CHICAGO BUILDER AND ASSOCIATE OF GIANCANA, ADVISED INFORMANT THAT HE HAD A DINNER DATE WITH GIANCANA IN CHICAGO LAST WEEK. CHICAGO 6486-C\* ADVISED GIANCANA WAS NOT PRESENT OCTOBER 25 LAST, HOWEVER, JOHN MATTASSA, RETIRED CHICAGO POLICEMAN AND ASSOCIATE OF GIANCANA, EXAMINED SOME STOLEN MERCHANDISE BROUGHT IN BY AN UNKNOWN FENCE WHICH CONSISTED OF A COAT AND A DIAMOND PIECE. MATTASSA TOLD THE FENCE HE WOULD LOOK AT THE MERCHANDISE AND ATTEMPT TO DISPOSE OF IT FOR HIM. THE FENCE INDICATED THAT "NO ONE HAS ANY MONEY THESE DAYS AND HOT GOODS ARE HARD TO GET RID OF." THE FENCE INDICATED THAT NO ONE HAD ANY MONEY BECAUSE OF ALL "THE HEAT" REFERRING TO THE PRESSURE EXERTED ON THE HOODLUMS UNDER THE INTENSIVE INVESTIGATION PRESENTLY BEING CONDUCTED BY THIS OFFICE UNDER THE NEW FEDERAL LEGISLATION. PHYSICAL SURVEILLANCE CONDUCTED THIS DATE ON DOMINIC BLASI REVEALED HIS PRESENCE IN RIVER FOREST, ILLINOIS, AND THE FACT THAT HE WAS APPARENTLY MEETING WITH INDIVIDUALS IN HIS, BLASI, HOME, HOWEVER, GIANCANA'S PRESENCE WAS NOT NOTED. ARMED AND DANGEROUS.
