THIS DATE THAT SHE WAS IN CONTACT LAST NIGHT WITH INDIVIDUAL KNOWN TO HER AS DICK BURNS, DESCRIBED AS WMA, WELL BUILT, FIFTY YEARS OF AGE, FROM NORTHWESTERN SUBURB OF CHICAGO, WHO WAS TALKING TO ANOTHER PERSON. BURNS WAS OVERHEARD DISCUSSING THE FACT THAT HE WAS LEAVING LAST NIGHT FOR SAN JUAN, P. R., WHERE HE WAS TO SET UP A GAMBLING CASINO. THIS DESCRIPTION MATCHES THAT OF RICHARD BERNAS, AKA, DICK BURNS, CLOSE ASSOCIATE OF GIANCANA WHO IN THE PAST HAS BEEN UTILIZED TO BUILD GAMBLING CASINOS. AIRLINES BEING CHECKED TO ASCERTAIN VERACITY OF THIS INFORMATION. SA BURTON HOMA, IRS, ADVISED THAT HE HAS ASCERTAINED THAT GIANCANA IS IN ENGLAND, ALLEGEDLY WITH PHYLLIS MC GUIRE.
