SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6486-C\* ADVISED OF NO PERTINENT ACTIVITY OVER THE WEEKEND. CG 6343-C\* ADVISED THIS DATE THAT ANTHONY ACCARDO, FRANK FERRARO AND JACK CERONE DISCUSSED THE FACT THAT "HE" SHOULD BE BACK FRIDAY OR SATURDAY. BELIEVED MAY HAVE BEEN REFERRING TO GIANCANA. RE INFORMATION THAT RICHARD BERNAS MAY HAVE GONE TO SAN JUAN TO SET UP GAMBLING CASINO THERE LAST WEEK, CG 6443-C ADVISED THAT AS OF NOVEMBER 19 LAST, BERNAS WAS WITH LESLIE KRUSE AND THE INFORMANT IN MCHENRY COUNTY, LOOKING OVER A PLACE AT LILY LAKE TO BE USED AS A GAMBLING SPOT. LOCATION IS IN A GARAGE, AND BERNAS IS TO DO THE REMODELING. ANOTHER INFORMANT HAS ADVISED THAT ONE DICK BYRNE, A PART TIME PRIVATE DETECTIVE, HAS BEEN MAKING NOISES AROUND CHICAGO TO THE EFFECT THAT HE IS "IN THE SYNDICATE." THIS MAY BE THE INDIVIDUAL REFERRED TO BY AN INFORMANT WHO WENT TO SAN JUAN. ARMED AND DANGEROUS.
