The information contained in this letterhead memorandum was furnished by SD 1061-CS to SAs JOHN W. JONES and ARNOLD D. ORRANTIA on 4/20/66. Source had just returned from a visit in Mexico City from 4/15 - 19/66, during which time, he had visited JORGE ROJAS MENDOZA. (u)

The source described in the letterhead memorandum is (SD 1061-CS) (u)

Previous correspondence in connection with ROJAS has set forth information regarding his alleged plans to visit Tijuana, B.C., Mexico, and to probably cross into the United States to visit friends in Los Angeles, California.

A separate 105 file is being opened on JORGE ROJAS MENDOZA in order to properly correlate information developed regarding this subject. Leads will also be set out to develop additional background information regarding him and to determine whether or not he, in fact, has a United States Border Crossing Card.

An extra copy of this letter is being furnished for transmittal to Legat, Mexico.
