This individual is probably identical with Michael Paul
Lamm, Bufile 100-445585, San Francisco file 100-85314. San Francisco
prepare brief descriptive information regarding Lamm in form
suitable for dissemination. It is noted this subject has been
in contact with the [Ad Hoc Committee] but this contact should not
be referred to in your LHM. (S)

It is noted that the RCMP letter indicated some of the
names to be recipients of letters from captioned committee were
given to members of the Progressive Workers Movement by Chinese
officials when the PWM group visited China in early 1966. RCMP
did not indicate if Lamm was one of those names. Legat, Ottawa,
attempt to determine if Lamm's name was in that list since it
would be very significant in our investigation of Lamm. (S)

Dear Sir:

A source of unknown reliability stated that The Canadian Committee Supporting Self Determination for the Peoples of Latin America (a pro-Chinese communist front) Vancouver, B.C., sent out letters, each containing a pamphlet which outlined the aims and the objectives of the organization, to the following individuals. According to the source, some of the names for the letters were given to members of the Progressive Worker's Movement (P.W.M.) (pro-Chinese communist) by Chinese officials when the former visited China in April and May, 1966. The source reported that Jerry LeBOURDAIS (a former leading member of the P.W.M.) stated that the Chinese officials indicated that these persons named were pro-Chinese in their political views and could be used as contacts.
