Re Tampa airtel dated 12/30/65.

Continued contact with Tampa sources has failed to reflect any activity by the "action" group of MIRR in the Tampa area. No information has been received from the U. S. Coast Guard or the U. S. Customs Offices in Tampa indicating any sabotage activity or further information to indicate that any such activity is contemplated in the Tampa area.

(u) SUBJECT ORGANIZATION  
[On 1/18/66 TP 225-S] advised that ENRIQUE SOMEILLAN, local delegate MIRR, was selling bonds, ostensibly for the purpose of raising money to help pay for the attorneys fees for the defense of ORLANDO BOSCH, head of the MIRR, who is under indictment from charges made by the U. S. Customs Agency Service, following his arrest in possession of explosives. According to the source, these bonds contained the return address of Post Office Box 322, Riverside Station, Miami 35, Florida. This informant indicated the bonds were in the amount of \$100 each. He furnished one such bond dated 12/17/65, number 0857, designated as "Special Issue Bond on Honor" and in the upper right hand corner in Spanish contained the printed statement, translated "reason is our shield ... we will fight until our country is free". The bond did not mention or contain the name of ORLANDO BOSCH. [Original information from this informant is contained in Tampa file 134-327A-23] (u) REC-10 97-4474-273

On 2/18/66 TP 52-S advised that the bonds which were sold by ENRIQUE SOMEILLAN and other members of the MIRR in Tampa, were actually in denominations of \$1's and \$2's each and that they were the method of raising funds from

members and friends interested in financially contributing to the above organization. These funds were not specifically designated as a fund for the attorneys fees of ORLANDO BOSCH.

TP 52-S advised that \$102 was raised by the delegation in Tampa and furnished to the Miami headquarters of MIRR on 2/11/66 at which time all of the remaining bonds were returned. TP 52-S advised that the local delegation of MIRR was not actively participating in the other activity at this time. (The original of the above information is contained in Tampa file 134-35A)
