ADMINISTRATIVE:

Investigation of this matter was reinstituted upon the receipt of information that the subject was maintaining a close association with JOSEPH FRANCIS CIVELLO (an identified member of La Cosa Nostra), and information that the subject-was actively engaged in bookmaking.

The purpose of this investigation is to ascertain if BOSCO is a member of La Cosa Nostra, the extent of his-bookmaking activities, and if he is possibly in violation of any Federal anti-gambling statutes.
