On April 12, 1966, DL T-3 advised that he has been acquainted with CUNZALO for about two or three years, and has known JOSEPH FRANCIS CIVELLO for about 35 years. (CIVELLO has previously been identified as a member of La Cosa Nostra). DL T-3 stated that from his knowledge of CIVELLO and CUNZALO, he would describe CUNZALO only as a "casual" friend of CIVELLO and they have been observed together by DL T-3 only at Italian funerals. DL T-3 has never heard CIVELLO, nor anyone acquainted with CIVELLO, speak of any association to any degree between CIVELLO and Informant was asked if it would be proper for CUNZALO. CIVELLO or CUNZALO to use the term "compadre" toward each other. Informant stated that this is a term of respect which is used between "equals" and is never used by a person addressing someone he considers his superior or his inferior. He further stated it would be quite proper for CIVELLO and CUNZALO to use this term when greeting each other.

On April 14, 1966, DL T-1 advised that he has never observed CIVELLO, PHILIP BOSCO, JOHNNY PATRONO or JOE IANNI at the Club Village or in any other contact with CUNZALO.

On April 1, 1966, DL T-4 advised that he has never observed CUNZALO at CIVELLO's liquor store, nor has he ever heard CIVELLO mention CUNZALO by name. DL T-4 further stated he has never heard of CUNZALO being engaged in any illegal activity.

DL T-5 on April 11, 1966; DL T-6 on April 12, 1966; DL T-7 on March 22, 1966; and Lieutenant JACK REVILL on March 28, 1966, each advised that they had no information that the subject was engaged in any illegal activity, nor did they have any information that the subject was a member of any Mafia type organization.

On April 15, 1966, Detective H. M. HART, Intelligence Unit, Dallas Police Department, advised that he has been checking CUNZALO's residence at least once a week for the past three months and has never noted any automobiles parked there other than those belonging to CUNZALO and his children.
