

CONFRONTED GIANCANA AT ARMORY LOUNGE TWO OR THREE MONTHS AFTER DIS-APPEARNCE OF FASEL. ACCUSED HIM OF BEING RESPONSIBLE FOR HIS DISAP-PEARANCE. GIANCANA FEINED INNOCENSE, HOWEVER, ADVISED INFORMANT THAT FASEL WAS QUOTE WRONG GUY END QUOTE AND WAS BURGLAR, ARMED ROBBER AND TOLD INFORMANT THAT FASEL KILLED A MAN ONE TIME. NOTED THAT DOMINICK CHRISTIANO. ACCOMPLICE OF FASEL IN RIVER FOREST. ILLINOIS BANK ROBBERY, WAS SLAIN IN NINETEEN FIFTY SIX. KNOWN, HOWEVER, THAT CHRISTIANO WAS SHOT BY GEORGE WILSON, ANOTHER ACCOMPLICE IN ROBBERY, AFTER WILSON HAD BEEN SHOT BY CHRISTIANO. GIANCANA APPEARED TO INFORMANT TO BE FULLY AWARE OF FASEL-S ACTIVITIES, AND KNEW OF EVERY OCCASION IN WHICH INFORMANT CAME IN CONTACT WITH HIM. SAID HE HAD JUST BEEN PAID BY EMPLOYER, EDMEIR TRUCKING COMPANY, CHICAGO. NOTHING WAS ILL REMOVED FROM FASEL-S APARTMENT, TO INFORMANT, AND HE DID NOT CASH HIS PAY CHECK. INFORMANT ACCOMPANIED AGENTS TO TIMBER TRAILS SUBDIVISION OF ELMHURST, ILLINOIS, WHERE IN-FORMANT STATES GIANCANA POINTED OUT HIS RESIDENCE. NOTED THAT THIS
