SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY.

RECORDS, ILL. STATE LIQUOR COMMISSION, CHICAGO, REFLECT NARDULLI AS SECRETARY OF MIST CLUB CORP., CHICAGO. NOTED THAT MIST CLUB HAS BEEN ALLEGED IN PAST TO BE UNDER GIANCANA-S CONTROL AND IS PLACE FREQUENTED BY GIANCANA. NAME OF FRANK NARDILE CARRIED AS LICENSEE OF AMBER LIGHT LOUNGE, CICERO, ILL. AMBER LIGHT MENTIONED PREVIOUSLY AS MEETING PLACE OF GIANCANA. FRANK NARDULLI, JR., STONE PARK, ILL., INTERVIEWED THIS DATE AND ADMITTED THAT HE IS SO CALLED SECRETARY OF MIST CLUB, BUT STATED THAT HE KNOWS NOTHING OF OPERATION, DID NOT CONTRIBUTE ANY MONEY TOWARD IT, AND DOES NOT KNOW NAME OF OTHER OFFICERS.

IS NOT ACQUAINTED WITH GIANCANA, DOES NOT KNOW NAME OF OPERATOR MIST, AND HAS ONLY BEEN IN ESTABLISHMENT ONLY ONE OR TWO TIMES.

STATED HE HAS NEVER HEARD OF AMBER LIGHT LOUNGE, CICERO, AND DENIED KNOWLEDGE OF BEING CARRIED AS LICENSEE. NARDULLI STATED THAT ABOUT

YEAR AND A HALF AGO, A PERSON WHOSE NAME NARDULLI STATES QUOTE I DON-T REMEMBER END QUOTE, CAME TO HIS HOUSE AND ASKED HIM TO SIGN

A PIECE OF PAPER STATING THAT HE WAS SECRETARY OF THE MIST CLUB. NARDULLI ASSISTED THAT IS THE EXTENT OF HIS KNOWLEDGE OF MIST. NOTED THAT

PROJECTIONIST AT ONE SIXTY PER WEEK. NOTED THAT ~~CENTRAL ENVELOPE CO.~~ <sup>ILL</sup>  
IS OWNED BY DETOLVE FAMILY, BROTHERS IN LAW OF GIANCANA. INFO IN  
DAILY SUMMARY OF APRIL FIVE LAST RE CHICAGO SIX THREE FOUR THREE  
DASH C ASTERISK STATING THAT GIANCANA IS QUOTE LONER AND STAYS OUT  
UNTIL THREE OR FOUR IN MORNING END QUOTE IS BELIEVED TO BE REFERRING  
TO GIANCANA BEHAVIOUR AND HABITS WHILE IN LAS VEGAS, SINCE UNKNOWN  
CONVERSANTS ARE PROBABLY FROM LAS VEGAS, OR HAVE JUST RETURNED FROM  
THERE. CHICAGO SIX FOUR FIVE SEVEN DASH PC ADVISED THAT GIANCANA  
COUNTS AMONG HIS CLOSEST ASSOCIATES, FRANK SINATRA, DEAN MARTIN  
AND PETER LAWFORD. CITED INSTANCES WHEREBY  
ARMORY LOUNGE WAS CLOSED TO PUBLIC, SINATRA AND MARTIN APPEARED  
AND GAVE PERFORMANCES TO SELECT GROUP OF GIANCANA ASSOCIATES. INFOR-  
MANT STATES THAT IN LATTER PART OF DEC., SIXTY, SHE WROTE LETTER TO  
GIANCANA, OUTLINING GRIEVANCES, PARTICULARLY RE DISAPPEARANCE OF  
FASEL, TOLD GIANCANA THAT IF HE SO DESIRED, HE COULD COME TO HER HOUSE  
AND ATAKE BACK EVERYTHING HE GAVE HER. DELIVERED LETTER TO <sup>ILL</sup> CARMEN  
FANELLI AT ~~ARMORY LOUNGE~~ <sup>ILL</sup> ~~FADEL AT ARMORY LOUNGE~~, WAS TOLD LATER BY FANELLI THAT LETTER WAS  
RECEIVED BY GIANCANA. GIANCANA DID NOT REPLY TO LETTER, AND HAOT  
MENTIONED IT. ONLY CONTACT WITH GIANCANA SUBSEQUENT TO LETTER  
WAS AT ARMORY LOUNGE, JAN., LAST, HOWEVER, SHE DID NOT CONVERSE WITH  
HIM. STATED LAST PERSONAL CONTACT WITH HIM WAS DURING LATTER PART  
OF NOV., WHEN HE AND BLASI CAME TO HER HOME, AND GIANCANA ADVISED  
THAT HE WOULD SEE HER AFTER CHRISTMAS, SAID HE WAS GOING OUT OF  
TOWN. SUBSEQUENT TO THAT, SHE WAS VISITED BRIEFLY BY BLASI, WHO
