SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY.

NICHOLAS D/AMICO, MENTIONED IN SUMMARIES APRIL TEN AND ELEVEN LAST, TELEPHONICALLY CONTACTED AGENT AND REFUSED TO BE INTERVIEWED PERSONALLY. ASKED ABOUT HIS INTEREST IN WAGON WHEEL GAMBLING OPERATION IN NORWOOD PARK, ILL., AND DENIED THAT HE HAD ANY INTEREST WHATEVER. HE WAS ASKED RE HIS RELATIONSHIP WITH SAM GIANCANA, AND STATED QUOTE I HAVE NOTHING TO SAY ABOUT THAT PERSON END QUOTE. HE WAS ASKED AGAIN ABOUT WAGON WHEEL, AND ADVISED THAT HE HAD NOTHING MORE TO SAY. CG SIX FOUR THREE THREE DASH C ADVISED THAT HE HAD LEARNED FROM LESTER KRUSE WHILE AT MGM LOUNGE, CICERO, THAT GIANCANA, ALEX, ROCCO FISCHETTI, AND ROCCO DEGRAZIO HAD PURCHASED LARGE BLOCKS OF SHARES OF STOCK IN ALBERTO DASH CULVER CORP., WHICH HAS A NEW PLANT IN MELROSE PARK, ILL. THESE SHARES WERE PURCHASED IN NAMES OF RELATIVES OF ABOVE PERSONS. DAY AFTER STOCK APPEARED ON NEW YORK STOCK EXCHANGE, PRICE WENT FROM TEN TO TWENTY FIVE DOLLARS PER SHARE.

NOTED THAT RECORDS OF AT&T CORP., NEW YORK, REFLECT SHARES OF THIS STOCK ISSUED TO DAUGHTERS, NEPHEW AND NIECE OF GIANCANA. THIS

SITUATION, WITH REGARD TO ALBERTO CULVER CO., WILL BE EXPLORED.

END QUOTE IS CLOSE TO GIANCANA AND IS UTILIZED BY GIANCANA FOR BOMBINGS AND ARSON JOBS. NOBILIO ALLEGEDLY WAS OWNER OF STANLEYS RESTAURANT AND RAILWAY LOUNGE AND RESTAURANT. INFORMANT ALLEGES THAT GIANCANA, FELIX ALDERISIO, AND NORTH SIDE HOODLUMS MEET REGULARLY AT YORKSHIRE ROOM OF PARK LANE HOTEL, CHICAGO. RE ROCCO PRANNO, GIANCANA/S REPRESENTATIVE FOR WESTERN SUBURBS, COOK AND KANE COUNTY, ILL.. INVESTIGATION AT AURORA DASH KANE COUNTY AMUSEMENT CO., REVEALS

THAT [REDACTED] PAREN FORMER INFORMANT WHOSE WHEREABOUTS ARE NOW UNKNOWN END PAREN WAS FORCED INTO PARTNERSHIP WITH PRANNO IN FIFTY EIGHT. CLOSE ASSOCIATE OF [REDACTED] FURNISHED INFO RECENTLY SUBSTANTIATING FACTS OF PRANNO/S TAKING OVER AURORA KANE COUNTY CO. BY FORCE. AFTER PRANNO/S REPUTATION AND TACTICS BECAME KNOWN TO THE COMMUNITY, BUSINESS SUFFERED BADLY. FINALLY IN OCT., SIXTY, [REDACTED] CAME TO HIS ASSOCIATE, STATED QUOTE I AM LEAVING, YOU WILL NEVER SEE ME AGAIN END QUOTE. UNDERSTOOD THAT [REDACTED] IS NOW IN LIQUOR BUSINESS IN WISCONSIN. FISUR CONDUCTED AT AURORA KANE COUNTY AMUSEMENT CO., APRIL ELEVEN LAST REVEALED A CLOSED VAN TRUCK REMOVING ALL FURNISHINGS FROM THIS CO., BORE NAME OF DONAN DISTRIBUTING CO., CHICAGO. DRIVER IDENTIFIED AS ONE BILL THOMAS, CURRENTLY IN THE EMPLOYE OF ROCCO PRANNO. INVESTIGATION CONTINUING. ARMED AND DANGEROUS..
