GIANCANA COMES IN OCCASIONALLY AND MAKES INQUIRY ON NEW CARS.  
UNABLE TO EXPLAIN DISCREPANCY OF NAMES OF REGISTRANT, COULD NOT RECALL  
IF PURCHASE WAS BY CASH OR CHECK. CG SIX FOUR FIVE SEVEN DASH C  
ADVISED THIS DATE SHE IS COMMENCING EMPLOYMENT AT KEY LOUNGE, STONE  
PARK, ILL., DESCRIBED PREVIOUSLY AS A GIANCANA OPERATION RUN BY ROCCO  
PRANNO AND MANAGED BY CARMEN MANNO, SON IN LAW OF GIANCANA. RECORDS,  
OAK PARK, ILL., NATIONAL BANK, SHOW A CHECKING ACCOUNT IN THE NAME OF  
SAMUEL AND BONITA GIANCANA, PRESENT BALANCE ABOUT TWO HUNDRED DOLLARS.  
ACCOUNT RARELY EXCEEDS LOW THREE FIGURE MARK, APPARENTLY UTILIZED  
PRIMARILY BY BONITA, DAUGHTER OF GIANCANA. BANK RECORDS ALSO SHOW  
THAT PROPERTY AT ONE THREE ZERO ONE MAPLE, BERWYN, ILL., SOLD BY  
CHARLES GIANCANA PAREN BROTHER OF SUBJECT END PAREN TO JAMES V. PERNO  
AND CHARLES TUMMINELLO, NEPHEWS OF SUBJECT. NOTED THAT THIS PROPERTY  
DESCRIBED EARLIER FROM RECORDS OF CAPITAL SAVINGS AND LOAN, CHICAGO,  
AS PURCHASED BY PERNO AND TUMMINELLO FOR SUM OF FIFTY FIVE THOUSAND  
DOLLARS, CARRIES MORTGAGE OF THIRTY FIVE THOUSAND. BANK OFFICIAL
