SAMUEL M. GIANCANA, AKA. AR. DAILY SUMMARY.

CG SIX FOUR FIVE SEVEN DASH PC ADVISED THAT DURING THE NIGHT OF APRIL
TWENTYFOUR LAST ROCCO PRANNO, PREVIOUSLY DESCRIBED AS A GIANCANA
LIEUTENANT HANDLING STONE PARK, ILL. AND OPERATING KEY LOUNGE,
THAT SUBURB, HAD. ACCORDING TO THE INFORMANT, BEATEN A BARTENDER IN
THE KEY LOUNGE ALMOST TO DEATH FOR QUOTE STEALING UNQUOTE. THE
BEATING TOOK ALMOST HALF AN HOUR TO BE ADMINISTERED AFTER WHICH THE
BARTENDER WAS THROWN OUT ON THE SIDEWALK. INFORMANT RELATED THAT
PRANNO INDICATED TO HER HE PLANNED TO UTILIZE OTHER GIRLS IN KEY LOUNGE
AS POSSIBLE PROSTITUTES. INFORMANT STATED THAT IN VIEW OF THIS
SITUATION, SHE ADVISED PRANNO THAT SHE NO LONGER DESIRES TO BE EMPLOYED
IN THE KEY LOUNGE AND GAVE HIM HER NOTICE. PRANNO ATTEMPTED TO

AN OPERATION OF THE QUOTE NORTH AVENUE STEAKHOUSE GANG UNQUOTE, INCLUDING GIANCANA MUSCLEMEN ROCKY ENFILICE, ET AL. INFORMANT WAS INTRODUCED THE OTHER NIGHT TO AMERICO DIPIETTO BY ENFILICE AS QUOTE THE BOSS UNQUOTE OF THE CREST LOUNGE. LIEUTENANT KEITH CAMPBELL, CLARK COUNTY, NEV. SO, CONCLUDED HIS INVESTIGATION IN CHICAGO RE JOSEPH PIGNATELLO AND DEPARTED CHICAGO FOR LAS VEGAS APRIL TWENTYFIVE LAST. CAMPBELL STATED HE DID NOT CONTACT RICHARD B.
