SAMUEL M. GIANCANA, AKA ., AR. DAILY SUMMARY. CHICAGO PCI ADVISED THAT GIANCANA AND QUOTE BUTCH ENQUOTE ~~BLASI~~, CHAUFFEUR AND BODYGUARD OF GIANCANA, OBSERVED FIVE THREE LAST ENTERING ARMORY LOUNGE, IN FOREST PARK, ILLINOIS. IT WAS PREVIOUSLY REPORTED THAT ~~GUS- STEAK HOUSE~~, CERMAK AND ROOSEVELT, CICERO, ILLINOIS IS A LARGE GAMBLING ENTERPRISE OF GIANCANA AND REPORTEDLY OPERATED FOR GIANCANA BY ONE FRANK QUOTE ~~SHARKEY~~ ENQUOTE ~~EULO~~. GUS KRINGAS, PART TIME BARTENDER AT GUS- STEAK HOUSE ADVISED FIVE THREE LAST ESTABLISHMENT OWNED BY HIS BROTHER GEO KRINGAS AND A PETER RANTIS AND DENIED KNOWING GIANCANA OR EULO. DURING INTERVIEW OF KRINGAS, EULO ENTERED STEAK HOUSE AND GREETED KRINGAS BY FIRST NAME. EULO IMMEDIATELY ADVISED BY A CUSTOMER OF ESTABLISHMENT THAT FBI WAS MAKING INQUIRY OF HIM. EULO SUBSEQUENTLY INTERVIEWED AFTER RELUCTANCY TO ADMIT IDENTITY. STATED THAT HE IS A GAMBLER BY OCCUPATION AND HAS OPERATED VARIOUS POKER AND DICE GAMES IN CICERO. CLAIMED THAT HE IS SOLE OPERATOR OF ~~THESE GAMBLING GAMES~~, AND THAT GIANCANA IS NOT CONNECTED WITH HIS OPERATION IN ANY WAY. STATED KNOWN GIANCANA FOR PAST THIRTY YEARS HAVING KNOWN HIM SINCE A BOY BUT CLAIMS NOT ACQUAINTED WITH GIANCANA- S ACTIVITIES. END PAGE ON

EULO ADMITTED THAT HE PRESENTLY IN CHARGE OF POKER AND CRAP GAMES OUT OF GUS- STEAK HOUSE AND THAT ONE MIKE BAKES HAS A WAGERING STAMP FOR A RACING WIRE SERVICE ALSO OPERATED OUT OF THIS ESTABLISHMENT. NOTED THAT ONE ~~MIKE BAKES~~ IS A LICENSEE OF THE ~~STOP LITE LOUNGE~~ IN CICERO, ILLINOIS AND THAT CG SIX FOUR FOUR THREE DASH C PREVIOUSLY ADVISED THAT STOP LITE IS ONE OF GIANCANA- S HEADQUARTERS WHERE A SAFE IS MAINTAINED FOR GIANCANA AND WHERE VARIOUS STOLEN MERCHANDISE REPORT-EDLY HANDLED. EULO AGAIN CLAIMED THAT HE IS SOLE OPERATOR OF THIS GAMBLING ESTABLISHMENT, AND HIS FORMER PARTNER FIVE YEARS AGO WAS ONE QUEENIE SIMONELLI, A FORMER CHICAGO PCI. STATED ALL HIS RECORDS CONCERNING HIS GAMBLING OPERATION MAINTAINED BY THE ~~D AND B BOOKING SERVICE~~ IN CHICAGO AND CLAIMED THEY WERE AVAILABLE FOR PERUSAL IF NECESSARY. CHARLES NICOLETTI PROVIOUSLY DESCRIBED AS A RAPIDLY RISING WEST SIDE HOODLUM AND LIEUTENANT OF GIANCANA INTERVIEWED FIVE THREE LAST CONCERNING HIS RECENT PURCHASE OF A NINETEEN SIXTYONE FORD FROM THE STERLING HARRIS FORD AGENCY. THIS FORD AGENCY REPORTEDLY WAS HOODLUM CONNECTED AND DISPOSED OF SEVERAL HUNDRED FORDS FOR BELOW COST PRICE ALLEGEDLY TO PAY OFF HOODLUM OBLIGATIONS. STERLING HARRIS FORD PRESENTLY INVESTI-
