ReNYairtel to Bureau dated 10/29/68.

On 10/25/68, NY 6436-C-TE (a member source) advised SA DANIEL R. KINNALLY there is a group of Cosa Nostra members in the Baltimore area under CARLO GAMBINO of New York.

Informant advised he attended the wake of FRANK CORBI's brother and at the wake informant was introduced to approximately fifty members of Cosa Nostra who were at that time under LOUIDICENA (ph.), a Capodecina. Informant advised that JOE FRANCO (deceased), formerly a Capodecina under ALBERT ANASTASIA, and CARMINE LOMBARDOSZI, a soldier, also attended CORBI's brother's wake and they represented the family from New York.

Informant also advised that he attended the wedding of the daughter of one of the Cosa Nostra members in a Baltimore hotel shortly after CORBI's wake and again met several Cosa Nostra members of the group which is now under CARLO GAMBINO.

Informant advised that FRANK CORBI took over from LOUIDICENA (ph.) and is now a Capodecina in the CARLO GAMBINO family and runs the group in Baltimore for GAMBINO. Informant stated this group in Baltimore is predominantly engaged in running the "strip joints" in that area.
