On 10/25/68, informant was contacted by SA DANIEL R. KINNALY and advised as follows:

In addition to other individuals who attended the Appalachian meeting, informant stated that RAYMOND PATRIARCA and JOHN LA ROCCA, who is from Pittsburgh, also attended this meeting. Informant did not believe these individuals had been discovered. Informant advised he did not know who summoned the meeting but it is his opinion it was called by the Commission.

In regard to the GAMBINO group in Baltimore, informant advised the group numbers approximately fifty members. Informant advised he attended the wake of FRANK CORBI's brother and at that time he met about fifty members in the Baltimore area who belonged to this GAMBINO group. It was informant's recollection that the wake took place about ten years ago. Informant advised that JOE FRANCO, a Capodecina in the GAMBINO family of Cosa Nostra and CARMINE LOMBARDOZZI, a soldier, attended this wake.

Informant advised that a LOUIDICIENA (ph.) was the Capodecina in Baltimore before FRANK CORBI and that FRANK CORBI took over as Capodecina after LOUIDICIENA stepped down. Informant did not know whether or not LOUIDICIENA is deceased. Informant also advised that CARMINE LOMBARDOZZI attended the wedding of one of the member's daughters shortly after the wake of CORBI's brother. Informant related that FRANK CORBI, as a Capodecina in the GAMBINO family, is directly responsible to CARLO GAMBINO and has been summoned in the past to New York City by GAMBINO. Informant advised the GAMBINO group in Baltimore is actively engaged in running the "strip joints" in that area.
