None of the sources utilized in rerep are member sources. All of the individuals, with the exception of CARLOS MARCELLO, are still considered suspected members as none have been identified by a qualified source.

NO 1457-C-TE, who is not a member source but is and has been intimately acquainted with CARLOS MARCELLO and his immediate family, deduced from his knowledge of meetings held by CARLOS MARCELLO that VINCENZO CAMPO has acted in the roll of mediator and JOSEPH MARCELLO, brother of CARLOS, is next to CARLOS in command. Source is not familiar with the terms "consiglieri" or "underboss" as they apply to the LCN organizational structure. These terms were used by contacting agent to equate the terminology used by the source to the accepted terms of LCN's organizational structure to show what source believes to be the chain of command in the Italian criminal organization in Louisiana.
